# Common Curriculum Update: Making it Easier to Administer and Fulfill the "Writing in the Major" Proficiency

SMU faculty have consistently expressed concern about the challenges of isolating the teaching of Writing Major to a single course, since many programs distrible teaching and practice of writing across a program. For the same reason, students on the Common Curriculum have struggled to find sufficient opportunities t the Writing in the Major requirement, even when they have spent several coursesing to write in accordance with the parameters of their discipline.

For this reason, on September 9, 2022, <u>Creuncilon General Education</u> approved a proposal to change how th <u>Common Curriculum</u> <u>Writing in the Major Proficiency and Experients</u> that the Degree Progress Report and replace it with one programe vel Writing in the Major student learning outcome.

Effective November 11the Writing in the Major Proficiency and Experience graduation requirement was removed from the Degree Progress Report for studewell tracking, and in fall 2023, we will begin tracking it through program learning outcomes and programevel assessment.

This approved change honors the true intent of the Writing in the Major Proficiency and values the tremen work done by faculty to develop Willagged courses, learning outcomes, and assessments. District to this new method of tracking and assessing Writing in the Major Office of Institutional Planning and Effectivenes will work closely with faculty and programs to write disciplispecific learning outcomes for Writing in the Major and to develop appropriate measures to assess this writing.

SMU's University Testing Center (UTIS) now a certified testing center by the ational College Testing Association (NCTA). The certification is a rigorus, oneyear accreditation process granted to those centers whose test administration policies are compliant with testing industry standards developed by the NCTA.
